# Vehicle type approval

## **The mandatory conformity assessment of manufactured in Russia or imported vehicles.**

Vehicle Type Approval must be obtained for the release of automotive equipment onto the market, whether it's produced or imported. Based on the VTA, Electronic Vehicle Passport or Electronic Chassis Passport for vehicles is issued, and the vehicle is registered. The document contains information about the manufacturer and technical specifications of the vehicle, confirming its compliance with the requirements of Technical Regulation No. TR CU 018/2011.





# Vehicle Design Safety Certificate (VDSC)

**The mandatory conformity assessment of manufactured in Russia or imported vehicles.**

MIC Center+ processes VDSC for manufactured in Russia or imported new vehicles. VDSC enables the issuance of an Electronic Vehicle Passport and the registration of the vehicle.



# Tire certification

**Tires certification for passenger cars, busses, trolleybuses, motorcycles, light and heavy-duties trucks.**

In the member nations of the Eurasian Economic Customs Union, it's obligatory to certify automotive tires as per the technical regulation known as "On the Safety of Wheeled Vehicles" TR CU 018/2011.

Pneumatic tires are assessed according to various schemes (1c, 2c, 3c, 4c, 9c, 11c). Tire certificates are issued either for a specific batch or for ongoing production and are valid for up to 4 years.





# Certification tests

**Preparation of test protocols for special-purpose vehicles, trailers, semi-trailers and tires.**

The accredited laboratory MIC Center+ conducts certification tests for vehicles, components, and tires to ensure compliance with the requirements of the Customs Union Technical Regulation TR CU No 018/2011.

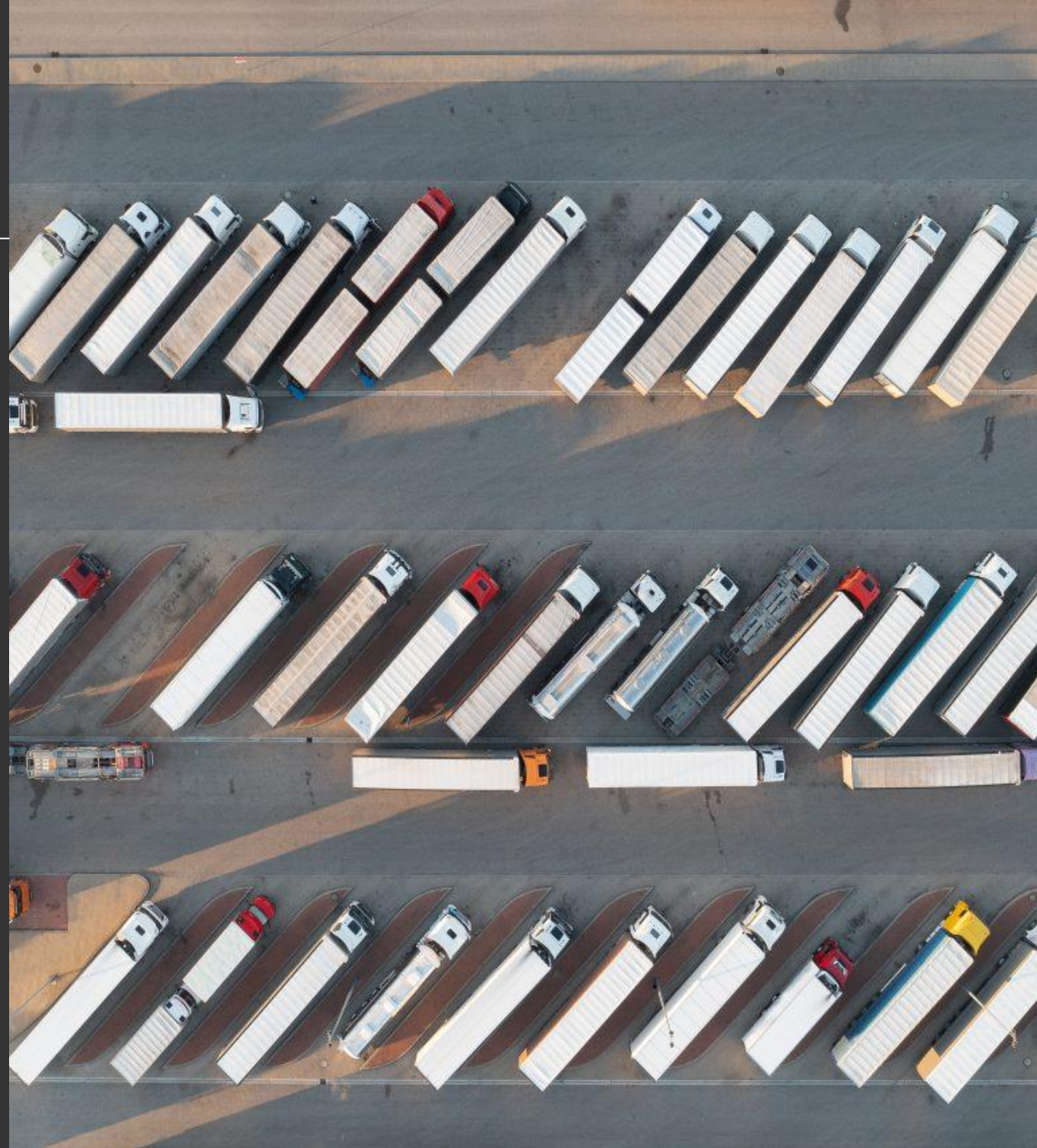


# WMI

## World manufacturer's identifier.

This certificate allows to become an official manufacturer of vehicles in Russia. By obtaining a WMI, you can get VTA or VDSC. Subsequently, you can obtain an Electronic Vehicle Passport and register the manufactured vehicle for sale.

A holder of a WMI can manufacture automobiles, special-purpose vehicles, trailers, semi-trailers and other types of vehicles in Russia. This document grants the right to apply your own marking to the vehicle.

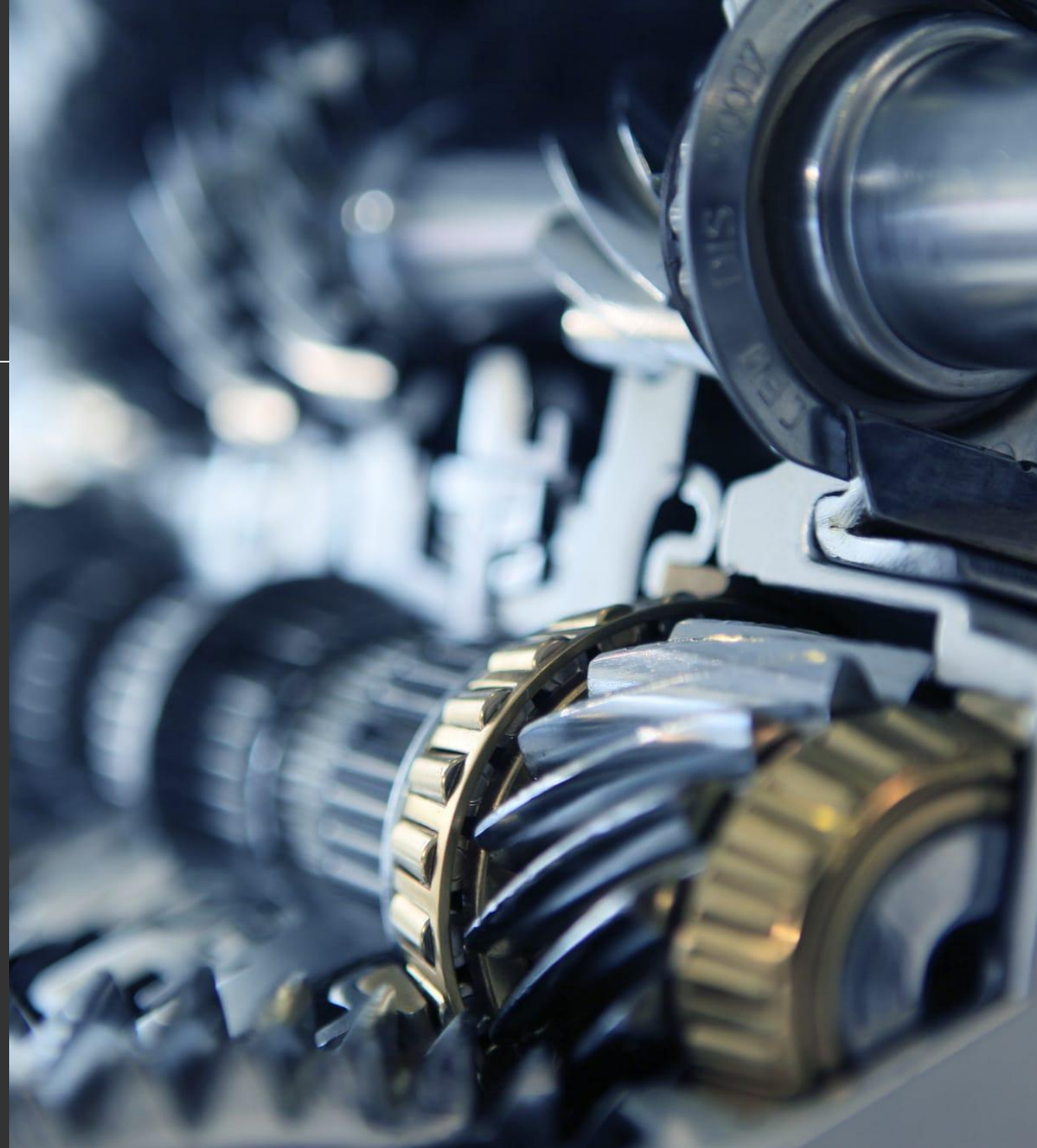




# Vehicle maintenance and repair certificate

## **Car service certificate.**

Voluntary certificate confirming the high quality of vehicle repair and maintenance services. The certificate verifies compliance of the provided services with GOST (State Standards) requirements and RD.

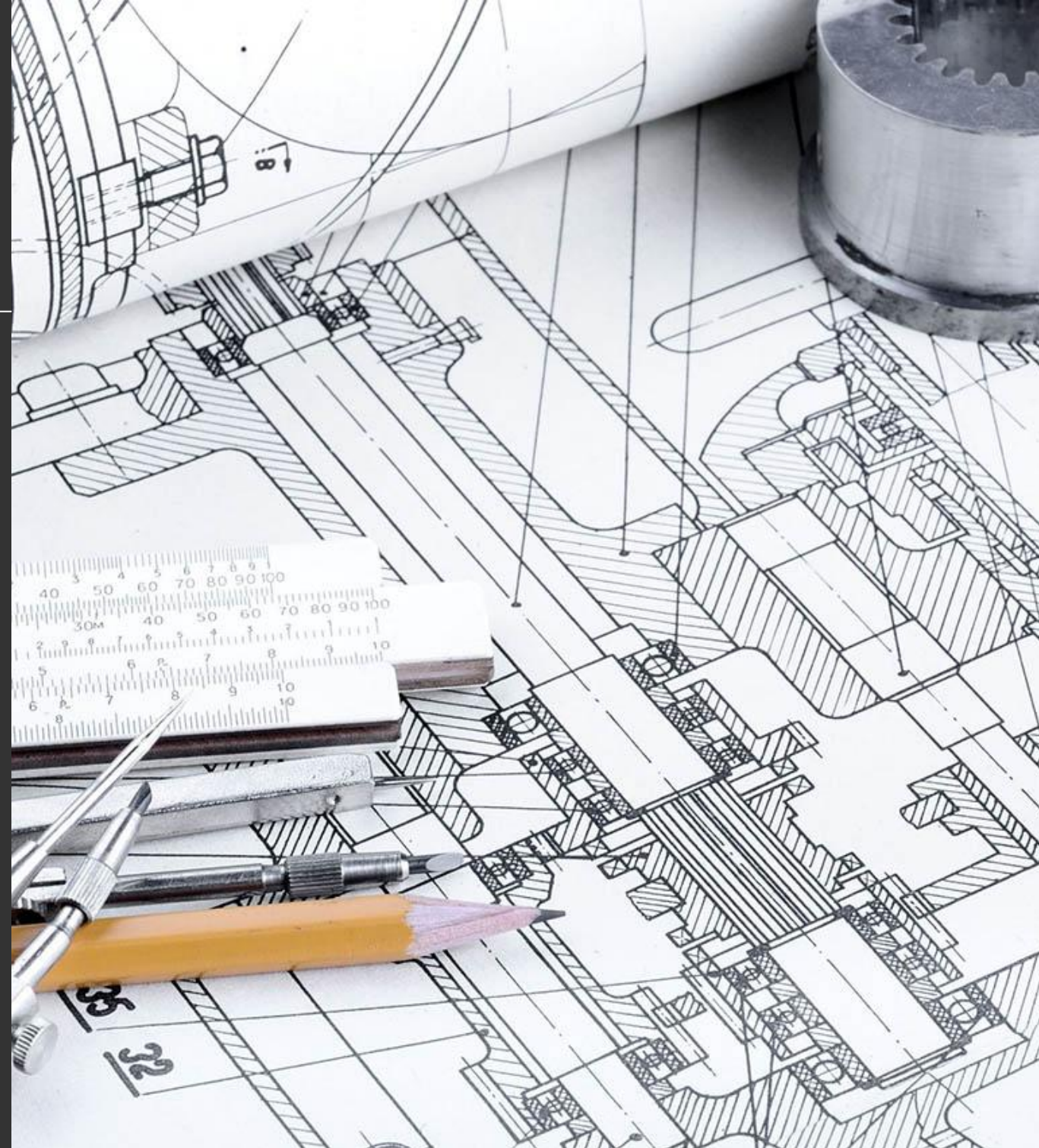




# Development of technical documentation

# ISO 9001 Certificate

## Quality Management System Certificate (QMS).

The ISO 9001 Quality Management System certificate confirms the company's compliance with international standards in the field of quality for organizing production processes. The document has a validity period of 3 years and is required when obtaining certificates of compliance for vehicle components, declaration of compliance, WMI certificates, and other documents.



# Division of responsibilities

## Mutual Obligations Protocol.

Division of responsibilities is required for obtaining VTA, VDSC. This document outlines the responsibilities for compliance with the technical regulation No. TR CU 018/2011 between the chassis manufacturer and the final vehicle manufacturer.





# Declaration of conformity

**The mandatory conformity assessment of products manufactured in Russia or imported.**

The document confirms that the product complies with the requirements of Technical Regulation TR CU No 018/2011, applicable in Russia and the Customs Union. The declaration is only issued for Russian legal entities and for products subject to mandatory or voluntary declaration.
